Legacy Village at Treeside consists of 20 fully leased units in 3 separate buildings. Two of the three buildings facing Treeside Drive are large three bedroom townhouse/style apartments with over 1,500 sq. ft. of living area each, plus a lower level with private 2 car garages that include washer/dryer hook-ups. These spacious units were built in 1962 and include one half bath on the 1st floor and one full and one half bath on the 2nd floor.

Sitting directly behind these units, is a ten unit garden style apartment building that was built in 1978. This building contains 8, two bedroom units and 2, three bedroom units and an on-site coin-operated laundry facility. All 10 have one full and one half baths and garages.

Renovations of these 20 units over the past few years consist of remodeled kitchens, bathrooms, new roof, gutters and almost all new windows.




















